

If integrated with other data sources such as CCTV, Digital Interviews or CSI images all the BWV footage can be viewed alongside these items to provide a complete view of all evidence as part of ongoing investigations.

Whilst EvidenceWorks® BWV is camera agnostic and will work with a range of BWV cameras vendors to provide an integrated solution, EvidenceWorks has recently been developed with our partner Edesix, to provide a fully integrated, scalable solution available from Lots 3 and 4 of the National Body Worn Video Framework.
